MIS is said to be effective in Organisation when 'right' information is provided to 'right' person at the 'right' time and at the 'right' cost. The College administration has part lot of efforts in this regard. The explanation to the above mentioned aspects is as follows:

1. Administrative procedures including finance: This is one of the best practice of the institution. For the purchase of various items of revenue and capital nature, a pre-determined and pre-decided procedure is followed. Various committees constituted for different purchases are required to open the quotations invited from three or more reputed suppliers of a particular items. The Committee recommends purchase of that item from a particular supplier considering number of parameters like price, quality, quantity, life durability, after sale service, guarantee and warranty about that items. Similarly for construction purposes, the building committee constituted, complete all procedure. Services of reputed experts like C.A., architect is taken from time to time.

- 2. Student Admission: For publicity of commencement of admission process the print and electronic media and college website on internet are used at the National and local levels. The advertisement appears in number of news papers in English and Hindi. The local electronic media covering a radius of 20 kms is also put to use for announcement of admission process well in time. The transparency in the admission process is ensured by implementing various norms of State Govt., University and other regulatory bodies related to fees for registration process etc. The class wise admission committees constituted with the instructions regarding minimum eligibility conditions, weightages for different activities, reservation of different types on the basis of community, geographical area, physically challenged persons etc. Merit lists is prepared and displayed on the notice board. As per schedule mentioned in the prospectus of the college (which is published every year) These merit lists for every course are displayed on the notice board showing the maximum and minimum percentage of the selected students under various categories. The cut-off percentages for various courses, keep on changing from year to year depending upon the quantitative and qualitative results of lower class.
- 3. Students record: College administration maintains the records of the students in a systematic manner and as per the statutory requirement of the regulatory bodies. The complete record for all aspects related to students is maintained by different employees dealing with different aspect. It may be related to admission, fees, attendance participation in various activities such as academic, cultural, sports, NCC, NSS and other co-curricular activities and information related to university such as registration, examination form, result, certificates and degrees, scholarship, awards etc.
- 4. Evaluation and examination procedures: The examinations work and processes are completely decided by the university as ours is an affiliated college. The internal assessment recently introduced by the University for UG and PG courses is sincerely implemented by the college staff and

administration. The pre decided criteria covering attendance of a student in the class, test, assignments, student's behaviour and personality, responsiveness in the class rooms etc. are taken into consideration while awarding internal assessment.

- 5. Research administration: with rapidly changing scenario of education the teachers need to be updated every time with latest research results in the different subjects and areas. The research activities are very useful for the growth of a teacher, development of an institute and society. One minor project had been completed by a faculty member. Taking the cue from the NAAC peer team which visited the college in 2016 to step up its efforts to obtain funds from various agencies like UGC for organising conference, seminars, workshops to engage the faculty members and students in research oriented activities. The initiative taken by the college has resulted into remarkable achievements in the field of research. Many papers and articles have been published in various reputed national and Inter-National journals by the faculty. The college provides seed money, travel expenses and registration fees for attending outstation seminars/workshops. The college has provided infrastructure and various other faculties for performing various research activities.

Others: The MIS in the college is successful in dealing with the various agencies and regulatory bodies such as universities, UGC, Government of Haryana, NGO and academic bodies demanding information from the college for different purposes. The information needed is furnished to the concern authority well in time to make the MIS relevant and effective.
